**AMENDMENT NO. 9 TO SCHEDULE 13D**

*This Amendment No. 9 to Schedule 13D/A (the "Amendment") relates to the Common Shares ("Common Shares") of Civeo Corporation, a British Columbia corporation (the "Issuer" or the "Company"). This Amendment is being filed to amend the Schedule 13D/A that was filed on August 16, 2022 (the "Schedule 13D"). This Amendment is being filed to update Item 5 to the Schedule 13D.
